Muskegon Maritime Academy, MMA, offers K-5 students an opportunity to develop robust Reading, Science, Technology, Engineering, and Math skills. We achieve this in tandem with water education and maritime research, in an environment that models the military values of discipline, respect, honor, and service. MMA is governed by restrictive laws, proper standard of conduct and behavior, proper language, basic commands, and actual facts. All students should conduct themselves in accordance with the code of conduct. Language is critical. Each student must use language to uplift the community. We believe there is always room for improvement and excellence is mandatory. The ultimate goal is to treat others the way we want to be treated.

The Parent Improvement Plan is embedded in our mission and vision. At MMA we plan to host three Title I meetings a year: October, February and April. The aim is to discuss the overall plan and implementation process of Title I. Moreover, we will ensure parents are involved in the planning, reviewing, and execution of the plan as well as the decision making process. More specifically, during the meetings we will discuss in detail the curriculum/content standards, State and local assessments, progress monitoring and resources available to all parents. We will use the website and monthly electronic newsletter to keep parents informed about the Title I plan.

MMA will convene a Title I Parent Meeting informing parents of the Title I requirements and their right to be involved by November 2, 2025. The annual meeting will include information for parents on: curriculum, assessments, proficiency levels, content standards, student progress, and advocacy. MMA will ensure that the Title I Parent

meeting is scheduled at a time convenient for all parents. Parents will be heavily involved and they will understand their right to be involved.

The development of the Title I Plan, will include all of the invested partners and stakeholders. We will discuss the Title I plan with individual, small and whole groups of parents at a time convenient for them. We will be clear as well as use a powerpoint presentation to ensure that the plan is understood by all parents. We will update the plan monthly.

All parents will be notified about the annual Title I meeting by phone calls, fliers, facebook post, and classroom by classroom communication. During the annual Title I meeting we will discuss the history of MMA, curriculum, discipline, important dates, special education policies and procedures, staff, paraprofessionals, assessment and the parents rights to be involved.

Convenient is defined as accessible, available, and timely in terms of location and time.

1116(c)(2) Offer flexible number of meetings at times convenient to parents and provide transportation, childcare, or home visits as it relates to parental involvement.

All Title I Meeting will be offered at times convenient for parents and if needed, transportation, childcare, and home visits will be arranged.

At MMA we will offer convenient meeting times as well as transportation and childcare. For parents who can not attend we will email and send home the powerpoint and notes as well as engage them before and after school.

In addition, we will share the minutes in our monthly newsletter, and we will share a survey during parent teacher conferences to further engage parents as well as receive feedback about the structure, convenience, and topics covered during the meeting. The survey will allow us to improve our Title I meetings in the future.

Again, convenient times are defined as accessible, available, and timely in terms of location and time. We will also survey the parents in terms of what convenience means to them.

The Parent and family Plan will be sent home to all parents at the onset of the school year and during parent/teacher conferences. Parents and families will be given a survey after the first Title I meeting for overall school improvement. During parent teacher conferences parents will be asked a series of questions relating to the Title I meeting. For example... Did you

attend the Title I meeting? What topics weren't covered that you wanted covered?

If you didn't attend the Title I meeting, why? Was the time. Location and date convenient? Did you have transportation? Was the Powerpoint and notes helpful?

At MMA we will ensure that our parents are involved in an organized meaningful manner. We will share the PIP during parent/teacher conferences. We plan to invite small groups of parents to table talk conversations throughout the school year. We will share the budget/plan during the table talk meetings throughout the school year.
